Ramp Update. We have established a Ramp Committee. It consists of members with engineering and construction backgrounds and the Board represented by the Commodore and Vice Commodore. Current members are Rich Altarcado and Chuck DeLucci who have developed an approach and are near presenting a plan & cost estimate to the Board; Craig Hobday, Tim Boggs and Alex Carl have weighed in with drawings (Tim Boggs and Steve Johnson), bids (Craig Hobday) and willingness to serve on the committee (Alex) based on their construction and engineering expertise. The Committee has come up with four proposals to repair our ramp:

Rich Altarcado & Chuck DeLucci. Welded structure on top of existing ramp with a beaver-tail at the end., length and pitch to be determined. Drawings (\$2,000), engineering design (\$5,000), cost (including environmental) TBD.

Tim Boggs. 40-feet of railroad rails and cleats topped with steel plating with McNichols bar grating, pilings and rubble at the end, cost (including environmental) TBD.

Steve Johnson, Port Captain. Concrete with rebar addition to the end of existing ramp over rubble and crushed rock (150 tons/yards), cost (including environmental) TBD.

Craig Hobday. Nordic Industries. \$275,437 (not including environmental) for a complete removal of existing ramp, addition of rubble to create new ramp of rubble and crushed rock (695 tons/yards). The Committee will be meeting monthly for a while.

The Committee is weighing the different approaches and should identify a preferred repair that will be developed in detail.

Steve Johnson, our Port Captain will serve as Chair, Thurman Watson, our Vice Commodore in his absence.

We are limited as to what we can do with the slope of our ramp. To make it steeper requires its demolition and replacement, environmental clearances (can take up to two years, cost \$70,000), costs of \$300,000 to \$800,000 which the Board decided is not reasonable for the Club.

We have discussed the approaches above and are pursuing one that will lengthen our ramp. permit launching for more boats near low tide and not require environmental studies and permits.

Road from Upper to Lower Parking Lots. Some of the pot holes have been filled. Watch your speed on this section. We have received a \$29,000 proposal to asphalt (2" thick, 7,600 sq ft, expected to last for 10 years) the road. We have provided the Lake Washington Sailing Club and River City Rowing Club a copy of the bid and asked if they would be willing to contribute to the cost. We will know more March 12th when all the Clubs meet for our quarterly Peninsula Users Group (PUG) meeting. We have received City of West Sacramento permission to pave the road.

Trailer Spaces Parking Policy

The limited trailer parking spaces inside and outside the gate are for members of the Port User Group (PUG), i.e., the Washington Outboard Club, River City Rowing Club, Lake Washington Sailing Club, and the UCD women's and men's rowing clubs.

There are signs posted that state "Parking for vehicles with trailers for the Port User Group". During the striper "season" in the port (generally October thru mid-March), traditionally those limited trailer parking spaces have been mostly used by members of WOC.

But the trailer parking spaces are open to all and not limited to just WOC during this heavy-use time.

Please beware of this policy and pass it along to other members as questions arise.

Some items to be aware of due to numerous "incidents" at our facility:

Fishing from the Docks Policy. W.O.C. members can fish off our and the LWSC dock. We are not permitted to fish off the Rowing Clubs docks. When a member is launching or retrieving their boat the member fishing from either of the docks must relocate or remove their rigs and gear from the water and dock so as to not hinder boating members. Rod holders are not be placed on ramp poles or signs.

Use of Our Gate, Launching and retrieving Your Boat Policy.

Members are required to lock the gate after entering or leaving unless another member says they will lock the gate.

It is expected that all members will completely rig your boat before approaching the launch ramp.

Approach the ramp on the extreme left side of the inner parking lot. Make a wide right turn before the sailboats on the point, stopping just before the ramp when another member is launching or retrieving their boat. When the

ramp is free continue your turn clearing the LWSC Clubhouse and back your trailer in. Pull out and park your trailer inside or outside our gate.

There are two trailer parking spaces next to the LWSC Clubhouse and several against the rowing club's barn. Do not block the "V" area to the right of the 2nd parking space to the right of the LWSC Clubhouse and to the left of the 1st barn trailer space as this is for Rowing Club skull access. Also, do not park in the last two cement pad spaces if being used (e.g., exercise equipment, exercise pads, etc. are there) as this is for Rowing Club access and exercise equipment.

It may be difficult to launch or retrieve your boat on a low tide. I have a 20' Northriver with a tandem trailer and can normally launch or retrieve it at 3.0' low tide. Any smaller tide and I have to wait. Remember that there are two red marks on the side of our ramp. The first one also has a red mark on the ramp. If the red mark on the ramp is out of the water proceed with caution. The second red mark and the "End of Ramp" sign on the dock indicate the extreme farthest point your trailer wheel hub should reach. Check out our web site http://washingtonoutboardclub.org/ Tides tab for the tides before your trip. The third column of tides is for the Port. Remember to add one hour during daylight savings time.

Upon take out pull all the way to our gate or outside it in order to de-rig your boat so as not to block other members launching or retrieving their boats.

I've attached a very rough sketch of our area inside and outside the gate areas. It shows the number of trailer parking spaces inside our gate (9) and outside (8). It also demonstrates where to rig and de-rig your boat and how to approach and depart the ramp. I apologize for its poor quality but I hope it is better than no illustration of our use of the ramp.

Make a wide right turn before the sailboats on the point, stopping just before the ramp when another member is launching or retrieving their boat. When the ramp is free continue your turn clearing the LWSC Clubhouse and back your trailer in. Pull out and park your trailer inside or outside our gate.

There are two trailer parking spaces next to the LWSC Clubhouse and several against the rowing club's barn. Do not block the "V" area to the right of the 2nd parking space to the right of the LWSC Clubhouse and to the left of the 1st barn trailer space as this is for Rowing Club skull access. 2020-2021 Renewals. We have had 540+ mail-in renewals as of our September 30th closure date. At the October 6th Board Meeting a motion was made and approved (with one abstention) to extend the renewal membership deadline to November 17, 2020 (the last date for 2020 new member sign-ups). Some items to be aware of due to numerous "incidents" at our facility:

Fishing from the Docks Policy. W.O.C. members can fish off our and the LWSC dock. We are not permitted to fish off the Rowing Clubs docks. When a member is launching or retrieving their boat the member fishing from either of the docks must relocate or remove their rigs and gear from the water and dock so as to not hinder boating members. Rod holders are not be placed on ramp poles or signs.

Use of Our Gate, Launching and retrieving Your Boat Policy.

Members are required to lock the gate after entering or leaving unless another member says they will lock the gate.

It is expected that all members will completely rig your boat before approaching the launch ramp.

Approach the ramp on the extreme left side of the inner parking lot. Make a wide left turn before the sailboats on the point, stopping just before the ramp when another member is launching or retrieving their boat.
