Old Business:

Commodore Gary Voet:

Budget June 1, 2018 to May 31, 2019. We should have \$10,000 to carry over from 2017-2018. We should end the 2018-2019 year \$30,000 positive for \$40,000 in our account at the start of our 2019-2020 year.

Launch Ramp. The ramp is serviceable for the foreseeable future. Remember to elevate your motors prior to launching or retrieving your boat at all times but particularly at low tide. Member Calvin Gladden, a professional launch ramp/dock contractor will look at the ramp and get back to the Commodore with recommended repairs and costs. A question was raised as to whether the Sailing club pays its share of ramp repair costs. The Commodore indicated the Sailing Club is $1/6^{th}$ our size and the intent is that they pay their share as costs incur. The Commodore indicated that the Peninsula Users Group (PUG) agreement limits Sailing Club expenses to "funds available".

April Steak Dinner. 89 attended. Our target was 150. We are a 501c7 tax-exempt social organization. We can subsidize to a certain degree activities that benefit our members. We will analyze costs, income and consider such activities on a case-bycase basis.
